







### **EXECUTIVE SUMMARY**

The University of Illinois Chicago (UIC) and its academic health enterprise, UI Health, are seeking a passionate and innovative leader to serve as Executive Director for the Mile Square Health Center, a designated Federally Qualified Health Center that is part of the University's health sciences system. The University of Illinois Hospital and Health Sciences System (UI Health) incorporates the training and research activities of the seven health sciences colleges, with the state's primary public hospital and clinics, the University of Illinois Cancer Center, and the Mile Square Health Center network of clinics—all with the aim of serving communities in Chicago and throughout the state in the pursuit of health equity.

### MILE SQUARE HEALTH CENTER

The UI Health Mile Square Health Center (MSHC) provides comprehensive primary care for children and adults of all ages through primary care clinics and school-based health centers. Our service area covers most of the West and South Sides of Chicago and portions of Cicero and the Rockford area. Our patients come from predominantly under-served and marginalized communities, many of whom live at or below the Federal Poverty Level, have public insurance, or are uninsured. MSHC provides care for all patients regardless of their ability to pay. Financial assistance is provided on

a sliding scale, which is based on family size and the Federal Poverty Level.

MSHC was established on Chicago's near West Side in 1967. The multi-service facility grew so quickly that by 1985, it was the largest federally funded community health center between the East and West coasts. In the late 1980s, beset by a lack of funding, MSHC temporarily closed its doors. In 1990, a unique partnership with the City of Chicago Department of Public Health, UIC and its health system, Mile Square Health Center was re-established and opened services once again in 1991. The facility was owned by the City of Chicago Department of Public Health and was staffed and managed by the University.

In 1999, MSHC became an official component of the University of Illinois Chicago, becoming one of the few public sector Federally Qualified Health Centers in the nation. In 2020, Mile Square expanded beyond the Chicagoland area by opening a site in the city of Rockford. Today, Mile Square offers medical education programs for physicians, nurses, certified nurse midwives, and pharmacy, social work, and dental students while providing high-quality, accessible healthcare for the community. MSHC continues to thrive and expand to meet the unmet healthcare needs throughout the Chicagoland area.

### **UI HEALTH**

Excellence in health sciences research spans many fields of study: from cancer biology to drug development; and healthcare delivery design to genomics, pharmacogenomics, robotic surgery—and many more.

UI Health is dedicated to the pursuit of health equity and is committed to training the healthcare leaders of the future. More than 30% of the students enrolled at UIC's health sciences colleges self-identify as part of different underrepresented groups. As the state's principal educator of health professionals, we also have an immense impact on the training of the state's healthcare workforce:

- 1 in 8 practicing Illinois physicians received their MD degree from the College of Medicine.
- Over 1 in 3 Illinois pharmacists trained at the College of Pharmacy.

- Over 8,000 practicing Illinois nurses trained at the College of Nursing.
- More than 1 in 3 Illinois dentists trained at the College of Dentistry.
- Nearly 1 in 4 Illinois social workers trained at the Jane Addams College of Social Work.

UI Health provides a wide range of specialty, primary and emergency care services. As the state's only public academic health enterprise, UI Health remains committed to serving the diverse needs of all patients who seek their care among our more than 40 care delivery locations. Our hospital and clinics see more than 65% Medicare/ Medicaid patients annually, and the College of Dentistry is among few Medicare/ Medicaid providers of oral health services for the state of Illinois. UI Health is home to many ground-breaking and innovative ways of delivering care to those who need it most:

## MILE SQUARE HEALTH CENTER EXECUTIVE DIRECTOR SUMMARY

The Executive Director is the Chief Executive Officer (CEO) of Mile Square Health Center and is responsible for directing the day-to-day management and operation of the Mile Square Health Center clinics. Mile Square Health Center reports to the Vice Chancellor for Health Affairs of the University of Illinois Chicago in conjunction with the Mile Square Health Center Co-Applicant Board of Directors.

The selected candidate will be administratively responsible for an organization delivering health care to historically underserved populations with multiple clinical locations throughout Chicagoland and across Illinois; totaling over 300 academic and nonacademic employees, serving over 54,000 unique patients annually.

UIC seeks an innovative and compassionate leader who will bring strategic and operational experience, keen organizational, planning and facilitation skills; excellent relationship-building skills and experience in a complex university, public sector, nonprofit or other setting. This is an extraordinary opportunity for a transformational health care leader committed to social justice and eager to make an impact and contribute to helping a dynamic health care operation fulfill its mission of providing exceptional medical services to the communities it serves.

### **Essential Responsibilities**

- Directs day-to-day management and operation of the
  Mile Square Health Center and takes the lead role in the
  establishment and implementation of administrative policies
  and procedures relating to daily operations. These include the
  functional areas of primary and specialty care, nutrition services,
  health education, social services, laboratories, pharmacy
  services, dental services, medical records, research, and grant
  and development functions.
- Ensures that staffing and operation of the Mile Square Health Center is accomplished in accordance with the Co-Applicant Agreement and the policies and procedures of the University of Illinois (University).
- By leadership and example, establishes standards of courtesy and service for the organization.
- Works with physicians and other health professionals to deliver excellent, high quality health care services.
- Ensures that appropriate linkages are established and effectively



maintained between the Mile Square Health Center, the University of Illinois Hospital & Clinics (UI Hospital), and other health systems for radiology, specialty, emergency, and other services to ensure quality and continuity of care.

- Ensures that appropriate linkages are established and effectively
  maintained between the Mile Square Health Center and other UI
  Health entities, including the seven health sciences Colleges, so
  as to ensure collaboration, quality and continuity of care.
- Serves as an ex-officio member of the Mile Square Health Center Board of Directors and provides routine and special reports, as well as other administrative services, as necessary. Works with the Board in resolving issues affecting service delivery or overall health policy as appropriate.
- Develops an annual operating budget for the Mile Square Health
  Center including gross clinical expenses, annual University
  contributions, and estimated patient care receipts for submission
  to and approval by the Mile Square Health Center Board of
  Directors and the University. Manages and monitors fiscal affairs
  of Mile Square Health Centers on an ongoing basis to ensure the
  achievement of budgeted results, the fulfillment of contractual
  requirements, compliance with applicable regulations and
  policies, and effective grants management. Provides routine
  financial reports to the Vice Chancellor for Health Affairs and
  other University leadership, as appropriate.
- Develops and garners additional sources of revenue by grant proposal writing and a thorough knowledge of available funds and healthcare funding sources. Effectively engages in philanthropic/advancement efforts.
- Evaluates future opportunities for growth and expansion consistent with the mission of the Mile Square Health Center.
- Monitors and evaluates performance and ensures that action is taken to correct any unsatisfactory condition. Cooperates

- with the University in ensuring compliance with all local, state, and federal codes (i.e., HRSA: Health Resources and Services Administration), ordinances, regulations, audits, and laws applicable to Mile Square Health Center.
- Develops and maintains effective relationships with the community, governmental organizations, national societies, and organizations.
- Performs other related duties and participates in special projects as assigned.



#### **ABOUT CHICAGO**

UIC is in Chicago, the third largest city in the United States, and an important global hub for culture and commerce.
